

Cookie policy

I. Who is responsible for the cookie policy?

Legalis advocaten bv (hereinafter: 'Legalis advocaten'), with registered office at 3980 Tessenderlo, Eersels 56, registered with the Belgian CBE with company number 0865.150.126, to be reached via info@legalis.be, or on the telephone number 013/67.12.01, attaches great importance to your privacy. In order to guarantee the proper functioning of our website and consequently of our services, our website uses cookies. These are collected in accordance with the relevant legislation in force.

II. Scope of application

This cookie policy applies to our entire website (www.legalis.be), including all related pages, both current and future.

III. What are cookies, what types are there and what are they for?

Cookies are small (text) files or data with a unique code that are stored between the browser, server and the hard drive of your device when you consult our website. They store certain preferences, settings, specifications and/or other limited information in order to guarantee the proper functioning of the website. There are also cookies that are used for analytical or marketing purposes.

Cookies do not contain harmful software and cannot install harmful software on your device.

There are different types of cookies. First of all, it is important to distinguish between 'first party' cookies and 'third party' cookies:

- **First party cookies** are only placed by the website itself. They ensure that the website functions properly and that your preferences are remembered.
- **Third party cookies** are then placed on the website by a third party with a different domain name. They serve to make your user experience better and more personal.

These 'first party' cookies and 'third party' cookies can be further subdivided into, among other things:

- **Essential cookies** that are necessary for a website to function.
- **Functional cookies** that track information about your choices and preferences on a website.
- **Analytical cookies** that collect information about the behaviour of website visitors and the performance of the website. Based on the results, the website can be improved and visitors get a better user experience.
- **Marketing cookies** that track the surfing behaviour of website visitors and compile a user profile based on that, which is used to make the surfing experience more personal.
